PRESS TRUST OF INDIA New Delhi, 4 March

An expert panel of the country's central drug authority has recommended granting emergency use authorisation (EUA) to Serum Institute of India's COVID-19 vaccine Covovax for the 12-17 age group, official sources said on Friday.

The Drugs Controller General of India (DCGI) had approved Covovax for

restricted use in emergency situation in adults on December 28. It has not yet been included in the country's vaccination drive.

Prakash Kumar Singh, Director-Government and Regulatory Affairs at Serum Institute of India (SII), had submitted an application to the DCGI on February 21, seeking EUA for Covovax for the 12 to 17 years age group.

The Subject Expert Committee on OVID-19 of the Central Drugs Standard

Control Organisation (CDSCO) on Friday deliberated on SII's application and recommended granting EUA to Covovax. The recommendation will be sent to the DCGI for approval, sources said.

In the EUA application, Singh is learnt to have stated that data from two studies on about 2,700 children aged 12 to 17 years show that Covovax is highly efficacious, immunogenic, safe and well tolerated in this age group of children.

## Kirloskar feud: SC to hear KMD CMD's petition on March 15

The Supreme Court will hear on March 15 a plea by Kirloskar Brothers 1 rd (KBL) CMD Sanjay Kirloskar challenging a Bombay High Court order directing arbitration in a family feud related to assets.

A bench headed by Chief Justice NV Ramana was told by senior advocate A M Singhvi, appearing for KBL, on Friday that the other side has been taking benefit of the mediation and repeated adjournments of hearings in the case and is involved in promotional and other activities. "Taking advantage of the mediation and adjourning of the matter repeatedly and the other side is doing promotional activities, advertisements and my suit is stayed. The court directed twice its listing but it did not come up. They (other side) is taking benefit of the time period of the mediation, Singhvi submitted before the bench, also comprising Justices AS Bopanna and Hima Kohli. "We will list it on March 15," the bench said.

On February 4, the court was informed by KBL that the mediation by former apex court judge Indu Malhotra to settle the Kriloskar family feud has failed.

The bench had said it would then hear the case.

Earlier, the bench had asked industrialist Atul Chandrakant Kirloskar and 13 others, made respondents by KBL, to apprise it of their opinion on the issue of mediation to settle the matter.
